Stan Silas mentioned how he would like the issue of criminal history to be mentioned during the disparate impact section. He also stressed that partnership members should be getting the word out to various media outlets and through other means as such as city utility bills. Stanko Zovko mentioned that a paid advertisement on social media might help get the word out as well.

To end the planning session the group reviewed the symposium planner that Theresa James had created to ensure that everything has been assigned. Stanko Zovko stated that he would create a flyer for the event that could be used for distribution.
